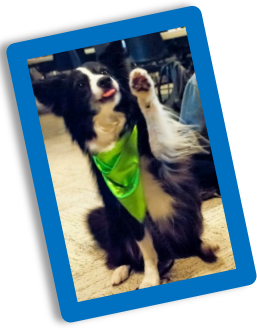
I am hoping this virus runs its course quickly, and we can all stay healthy through all of this. There will be other shows and events in the future.

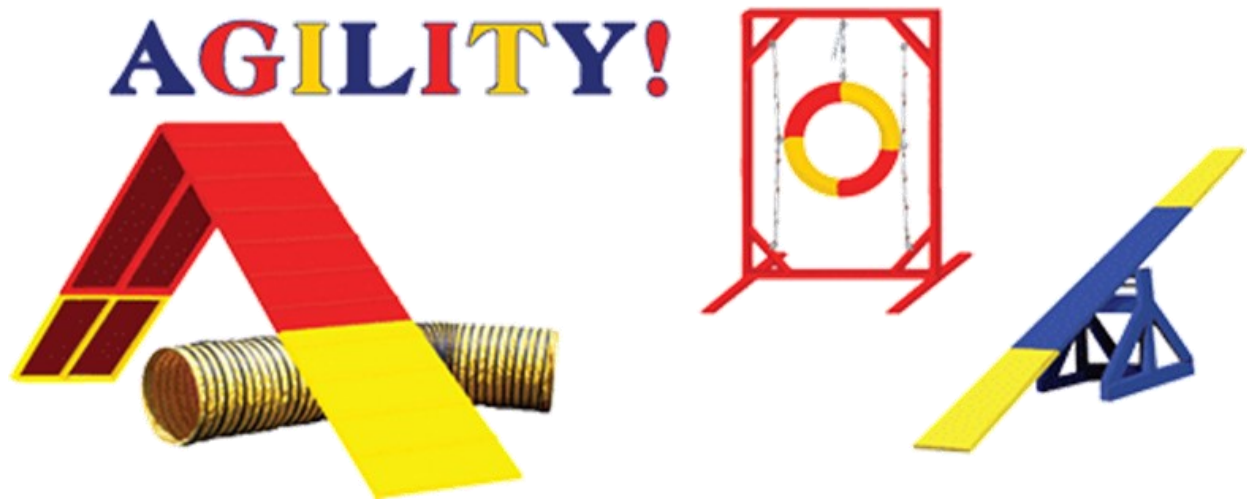
