- ____ Competitive Obedience – For those competing or wanting to compete to prove obedience commands
- ____ Utility – Proofing obedience commands for handler and dog teams working at this level
- ____ Rally – Signs describe obedience maneuvers to be performed
- ____ CGC – Proof 10 obedience exercises with the goal of obtaining the Canine Good Citizen Certification
- ____ Conformation – Ring performance etiquette and requirements for handler and dogs to perform at Breed Shows
- ____ Agility – Separate sign-ups; Pre-requisites
- ____ Nose-Work – Separate sign ups; Pre-requisites
- ____ Packerland Youth Program

Training Regulations

1. Family training fee includes husband, wife, and all children under 18, excluding married children. A child's age to train a dog on the floor in class is strictly up to the discretion of the Instructor of the Class. Parents and/or guardians will be held responsible for their children under 18 years of age and must be present if any child under the age of 18 is training on the floor.
2. Training fees are: (Per Calendar Year)
 \$75.00 per class to train one dog; \$25.00 for each additional dog or class in the same session
 Additional sessions for the same dog - \$65.00; \$25.00 for each additional dog or class in the same session
 (There will be a \$25.00 fee for checks returned NSF)
3. A certificate from your veterinarian verifying your dog has been vaccinated for Distemper, Hepatitis, Parvovirus, and Rabies (for dogs over 24 weeks of age) should be presented with your Training Application form before entering the first class. Dogs will not be allowed on the training grounds after the second training class if the above verification certificate has not been received and documented. All dogs brought to classes must be in good health.
4. **We do not allow dogs that are aggressive toward people and/or other dogs in our classes.** If your dog is aggressive toward people or other dogs, or otherwise causes a disturbance in class, you, and your dog will be directed to leave the class and no paid fees will be refunded.
5. **Packerland Kennel Club will not be held liable for any accidents.**
6. **No paid fees will be refunded after the first night of training.**
7. Trainees are not eligible to vote on Club matters, do not receive a mailed copy of the Club's monthly publication, and may use the outside exercise area by invitation only.
8. Any trainee may apply for membership after attending two (2) business meetings during the calendar year.

Release and Hold Harmless Agreement

Please read this release carefully and be aware that signing up and participating in Packerland Kennel Club training classes, you will be waiving and releasing all claims for injuries sustained by you or any member of your family arising out of this program.

As a participant in Packerland Kennel Club training classes, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of injuries, damages or losses which I, any member of my family, or my dog(s) may sustain as a result of participating in any and all activities with or associated with Packerland Kennel Club.

I further agree to indemnify and hold harmless and defend Packerland Kennel Club and its officers, instructors, and servants from any and all claims resulting from injuries, damages and losses sustained by me, any member of my family, and my dog(s) and arising out of connection with or in any way associated with the activities of Packerland Kennel Club.
