The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Movement between an "A" and "B" class at the same level is not considered a transfer – refer to Chapter 1, Section 16b.

TRIAL REGULATIONS

Trial hours are 7:00 am to 3:00 pm

- •NO ENTRY SHALL be made or accepted which specifies any condition to its acceptance.
- •ENTRIES SHALL NOT be accepted without signature and fees. All entries must be on official AKC entry forms.
- •ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances or other acts, including extreme weather conditions, beyond the control of the management; it is impossible to open or complete the show, no refund of entry shall be made.
- •POST-DATED CHECKS AND RETURNED CHECKS do not constitute a valid entry fee. Northeast Wisconsin Classic Obedience & Rally Trials will add a collection fee of \$20 to the amount of each returned check. If acknowledgement of entry is not received by exhibitor within a reasonable period of time, please notify the trial secretary.
- •NO REFUND FOR DUPLICATE ENTRIES. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.
- •ERRORS ON ENTRY FORMS. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
- •DOGS MAY ARRIVE any time prior to their scheduled time of judging. (The building will be open at 6:30 a.m.) Dogs not required for further judging will be excused.
- •NO DOGS will be allowed in the building overnight.
- NO SMOKING IN BUILDING.
- •NO PRIVATE exercise pens in the building.
- •EXHIBITORS must exercise their dogs in the designated areas and pick up after them.
- •JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.
- •ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged.





- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles). Poodles (toy, miniature, standard).
- 2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
