Obedience & Rally Transfers (will be allowed for these trials)

After a dog earns a title, it may be transferred to another class in a future trial, even though the closing date for the trial has passed. A transfer (i.e., from an obedience class to an obedience class or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Movement between an "A" and "B" class at the same level is not considered a transfer – refer to Chapter 1, Section 16b.

Transfer forms may be downloaded from the AKC website (www.akc.org) and/or will also be available at the secretary's table.

TRIAL REGULATIONS

Trial hours are 7:00 am to 3:00 pm

- **NO ENTRY SHALL** be made or accepted which specifies any condition to its acceptance.
- **ENTRIES SHALL NOT** be accepted without signature and fees. All entries must be on official AKC entry forms.
- **ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances or other acts, including extreme weather conditions, beyond the control of the management; it is impossible to open or complete the show, no refund of entry shall be made.
- **POST-DATED CHECKS AND RETURNED CHECKS** do not constitute a valid entry fee. Northeast Wisconsin Classic Obedience & Rally Trials will add a collection fee of \$20 to the amount of each returned check. If acknowledgement of entry is not received by exhibitor within a reasonable period of time, please notify the trial secretary.
- **NO REFUND FOR DUPLICATE ENTRIES.** Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.
- **ERRORS ON ENTRY FORMS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
- **DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.
- **NO DOGS** will be allowed in the building overnight.
- **NO SMOKING IN BUILDING.**
- **NO PRIVATE** exercise pens in the building.
- **EXHIBITORS** must exercise their dogs in the designated areas and pick up after them.
- **JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.
- **ALL DOGS PRESENT** must be held on leash or confined to their crates except when being judged.
- **CLASS CASH PRIZES** will be paid in the ring to the person showing the dog.
- **NO DOGS UNDER 6 MONTHS OF AGE ARE PERMITTED IN THE BUILDING.**
- **DOGS** found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment.
- **MCKC and/or PKC DO NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THESE EVENTS.**
- **TELEPHONE, FAX AND UNSIGNED ENTRIES** Cannot Be Accepted. Entries Not On Official AKC Entry Forms or Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE.** Entries received without fees will not be accepted.
- **MAIL OR HAND DELIVER** All Entries with Fees to Kathy Dachlet, 7821 Morrison Road, Greenleaf WI 54126.
- **COLLARS** - Pinch collars, electric or dummy collars are prohibited. Training collars are allowed.
- **REFUND OF BITCH IN SEASON** If your bitch goes into season after the closing date, a refund of entry fees (less \$8.00 per day for administrative fees) will be given. Such request of refund must be received by the trial secretary no later than the close of the Sunday trial.
- **REFUND OF INJURED DOG** If your dog is injured after the closing date, a refund of entry fees (less \$8.00 per day for administrative fees & all respective AKC fees (per class entered) will be given with written verification from a veterinarian. Such request of refund must be received no later than 7:00 p.m. Monday, September 29, 2025.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
